



COVID Compliance/Waiver for Little Movers and Shakers Music Classes

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Little Movers and Shakers has put in place preventative measures to reduce the spread of COVID-19; however, LMS cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending LMS could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the LMS Pod and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I agree to follow and enforce the guidelines set by LMS (agree to each below) and I understand that the risk of becoming exposed to or infected by COVID-19 at my LMS Pod may result from the actions, omissions, or negligence of myself and others, including, but not limited to, LMS employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the LMS Pod or participation in LMS programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the LMS, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the LMS, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in the LMS program.

FOR PARTICIPANTS OF MINORITY AGE (UNDER AGE 18 AT THE TIME OF REGISTRATION)

This is to certify that I, as parent/guardian, with legal responsibility for this participant, have read and explained the provisions in this waiver/release to my child/ward including the risks of presence and participation and his/her personal responsibilities for adhering to the rules and regulations for protection against communicable diseases. Furthermore, my child/ward understands and accepts these risks and responsibilities. I for myself, my spouse, and child/ward do consent and agree to his/her release provided above for all the Releasees and myself, my spouse, and child/ward do release and agree to indemnify and hold harmless the Releasees for any and all liabilities incident to my minor child's/ward's presence or participation in these activities as provided above, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent provided by law.

Covid Safety Protocols:

Your signature acknowledges that you agree to comply with each of these safety protocols

Hand-washing/sanitizing: All participants will be required to wash or sanitize their hands just prior to class start.

Temperature Checks: Temperatures will be taken before the start of each class, so please arrive on time in order to not disrupt the class. No one with a temperature will be admitted.

Masks: All adults present, and children over 3, including the instructor will wear masks covering noses and mouths as well at all times. If it is possible for your younger child to wear a mask, we would like them to wear one as well.

Social Distancing: All participants and the instructor will remain socially distanced throughout the class. Parents are responsible for enforcing this rule with their children. Please bring a blanket or towel to sit on.

Instruments and Props: Instruments and props will not be shared. Each child will bring their own.

Exposure: Each participant and the instructor are require to inform and not attend class if they or anyone in their family is ill, has a fever, or has been exposed to someone who has tested positive for Covid.

1 adult per child: If your significant other/grandparent wants the opportunity to experience the class with your little one, please get prior approval and make sure that they have signed a waiver. We cannot allow any drop in visitors.

Please promptly exit the area when your class is over (for park class only) : We want to make sure that the next class has an opportunity to safely enter the area and remain socially distant, so please do not linger after class.

Class Additions (for PODS only) : If any new participants wish to join a class they must be approved by the entire class and submit a compliance form to Little Movers and Shakers.
