



COVID Compliance/Waiver for Little Movers and Shakers Music Classes

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Little Movers and Shakers has put in place preventative measures to reduce the spread of COVID-19; however, LMS cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending LMS could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the LMS classes and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I agree to follow and enforce the guidelines set by LMS (agree to each below) and I understand that the risk of becoming exposed to or infected with COVID-19 at my LMS class may result from the actions, omissions, or negligence of myself and others, including, but not limited to, LMS employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the LMS Class or participation in LMS programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the LMS, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the LMS, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in the LMS program.

FOR PARTICIPANTS OF MINORITY AGE (UNDER AGE 18 AT THE TIME OF REGISTRATION)

This is to certify that I, as parent/guardian, with legal responsibility for this participant, have read and explained the provisions in this waiver/release to my child/ward including the risks of presence and participation and his/her personal responsibilities for adhering to the rules and regulations for protection against communicable diseases. Furthermore, my child/ward understands and accepts these risks and responsibilities. I for myself, my spouse, and child/ward do consent and agree to his/her release provided above for all the Releasees and myself, my spouse, and child/ward do release and agree to indemnify and hold harmless the Releasees for any and all liabilities incident to my minor child's/ward's presence or participation in these activities as provided above, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent provided by law.

Hand-washing/sanitizing: All participants will be required to wash or sanitize their hands just prior to class start.

Temperature Checks: Temperatures will be taken before the start of each class, so please arrive on time in order to not disrupt the class. No one with a temperature will be admitted.

Masks: In **mask-required** classes, all adults present, and children over 3, including the instructor, will wear masks covering noses and mouths at all times. In **mask-optional** classes, masks are optional when socially distanced on blankets, but required as stated above during any closer activities. Medical grade masks preferred.

LMS has to right to update stricter mask policies at any time as they see fit.

Social Distancing: All participants will bring blankets to sit on to remain socially distanced. Parents are responsible for enforcing this rule with their children. Closer group activities will be offered, but each family can choose their comfort level in participating. The instructor will adapt the activity to suit.

Instruments and Props: Each child will bring their own instruments and props. Instructors will bring some to share in a safe manner, but using them is at each family's discretion. (LMS will sanitize all after use.)

Exposure: Each participant and the instructor are require to inform and not attend class if they or anyone in their family is ill, has a fever, or has been exposed to someone who has tested positive for Covid.

Please promptly exit the area when your class is over: We want to make sure that the next class has an opportunity to safely enter the area and remain socially distant, so please do not linger after class.
